Kingsville Contractor Fined \$5,000 for Safety Violation

## Kingsville Contractor Fined \$5,000 for Safety Violation

Marcovecchio Construction prosecuted for unsafe digging practices and striking pipeline

**FOR IMMEDIATE RELEASE** (**Toronto, ON, July 25, 2016**) – The Technical Standards and Safety Authority (TSSA) successfully prosecuted Marcovecchio Construction, a Kingsville contractor, for hitting a gas pipeline, contrary to the Oil and Gas Pipeline Systems Regulation (Ontario 210/01).

The Ontario Court of Justice in Windsor accepted a guilty plea from Marcovecchio and fined the company \$5,000 plus the mandatory 25% victim fine surcharge for a total penalty of \$6,250.

In August 2015, a TSSA inspector received notice of a natural gas pipeline strike in Kingsville, Ontario and upon further investigation determined that the incident was the fault of Marcovecchio Construction Ltd. Marcovecchio hit the pipeline with a backhoe while installing sewer lines, which resulted in natural gas flowing freely into the atmosphere.

"This was a near miss for a potentially deadly scenario," said John Marshall, Director of TSSA's Fuels Safety Program. "Hitting a pipeline with pressurized gas can cause explosions, damage and death. That's why Ontario has stringent laws around pipeline safety, including the rule to obtain a locate before breaking ground," added Mr. Marshall.

TSSA reminds the public that any excavation work must comply with Ontario's safety laws, including obtaining a valid pipeline locate from the license holder or gas utility before breaking ground. Ontario Regulation 210/01 prohibits interfering with or damaging a pipeline and any damage and/or subsequent release of gas should be immediately reported to the Ministry of Environment's Spills Action Centre at 1-800-268-6060 or by contacting TSSA toll-free at 1-877-682-8772.
